

Privacy policy

This Privacy Policy explains how we use your personal information to book your seat on microinsurance conference and get notified with the latest events and agenda of the conference. This Policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. This policy applies to our website (www.lfegypt.net), to our mobile Applications software and to any other method introduced by the Company that allows for the automated seat booking on the conference. Primarily this Policy is relevant to our registered users, who use our Services. However, it is also relevant to website visitors who subscribe to our news from our website, and to general visitors to our website. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. By providing us with your personal information, you agree to it being used and disclosed in the manner set out in this Policy.

This privacy policy governs the manner in which "IFE" collects, uses, maintains and authorizes the information collected.

Personal identification information

IFE collects personally identifiable information from members in various ways, including, but not limited to, the times of the Application visits, registers with the Application, fills out an application to reserve conference seats, flight and hotel reservation, analyses a survey form, and other activities, services, features or resources that we may make available on the Application. Users may be asked to provide their full name, email address, phone number

Non-personally identifiable information

IFE collects some information about members wherever they interact with the application, and these informations are not related to personal identity, but may include the type of smartphone and technical information about the member's communication methods with the application, such as the company used to provide Internet service and other similar information

How we use the collected informations

IFE collects and uses members personal informations for the following purposes:

-Improving the quality of service

Your information help us to more easily respond to customer service requests and support needs

-To improve the application

We constantly strive to improve the offers offered through the application or our website in accordance with the informations and feedback we receive from you

Send emails periodically

The e-mail address that members register to process their request will only be used to send them information and updates related to their request. It may also be used to respond to inquiries, other requests or questions. If the user decides to join our mailing list, he will receive messages on his e-mail that may include news, latest updates, and information regarding the application. And if the user at any time wants to cancel the registration of receiving any future messages, we provide him with detailed instructions about cancelling the registration at the end of each message on his email, or the user can contact us through the application or our website

How we protect your information



We follow proper procedures and security standards in collecting, preserving and handling data, in order to protect that data against unauthorized handling, modification, disclosure or destruction of your personal data, user name, password, information about your transactions and data stored on our application. Sensitive and private data is exchanged between IFE and its users through secured communication channels and is encrypted and protected through approved digital methods and method

Sharing personal data

IFE does not sell, trade, or rent members personal identification data to third parties, and we may share aggregated general demographic information that is not linked to any personal identification information about visitors and users with our partners, affiliates and advertisers for the purposes described above. We may use a third party service provider to help us operate our business and operate the Application or to administer activities on our behalf, such as sending out newsletters or surveys. We may share your data with this third party within the limits of those specific purposes if you have given us permission to do so

Also, IFE may share your data as your name, phone number, e-mail with the e-channels that facilitate the payment methods.

We also do not share your data with any official government agency except with an official letter directed to our company to disclose your data personally in security or criminal cases

Third Party Websites

Users may find advertisements or other content on our App that contain links to the websites and services of our partners, suppliers, advertisers, sponsors, licensors, or other third-party entities. You should note that we do not control the content or links that appear on those sites and are not responsible for the practices of sites linked to our site. In addition, those websites or services, including their content and links, may change constantly. These sites and services will have their own privacy policies and customer service policies. Browsing and interaction on any other website, including websites that link to our App, is subject to those websites' own terms and policies

We encourage users to frequently review the Privacy Policy for any changes so that they are aware of what we are doing to protect the personal data we collect. The user acknowledges and agrees that it is his responsibility to review this privacy policy periodically and be aware of the modifications
